2023 COGEL Conference

Ms. Weber requested approval to attend The Council on Governmental Ethics Laws' (COGEL) annual conference on Sunday, December 3, through Wednesday, December 6, at the Westin Kansas City at Crown Center, Kansas City, Missouri. A motion was made by Mr. Harman that Ms. Weber be approved to attend the COGEL Conference in December 2023. Ms. Singleton gave a second, and the motion carried.

Approve P-card Monthly Reports

The Commission reviewed the P-card monthly reports for June and July 2023. A motion was made by Ms. Disibbio to approve the reports as presented. Mr. Harman seconded the motion, and the motion carried.

Legislative Rule

Ms. Kirk reported that the West Virginia Legislative Rule Making Review Division, in consultation with the Chairpersons of the Rule-Making Review Committee, has requested that the Ethics Commission withdraw its proposed Legislative Rule governing lobbyists, Title 158, Series 12. Ms. Kirk explained that the Ethics Commission's authority to promulgate rules relating to lobbyists and grass roots lobbying is very narrow and unclear in the Code. The Rule-Making Review Committee will request one of its attorneys to draft legislation to incorporate needed changes in the Act to clear up this technical ambiguity. The West Virginia Code allows state agencies to withdraw pending Legislative Rules. Once the proposed Rule is withdrawn, the Rule language remains in its existing form. Ms. Disibbio made a motion that the Commission approve the withdrawal of the proposed Rule. Mr. Cottle gave a second, and the motion carried.

Executive Session

Ms. Davis moved that the Ethics Commission go into Executive Session to consider VCRB 2008-20 Roger Wolfe (deceased) former Mayor of Dunbar, Estate of Roger Lee Wolfe's Application for Waiver of Lien on the Estate, pursuant to W. Va. Code § 6-9A-4(12) in the Open Meetings Act and the attorney-client privilege, and to consider settlement terms in a proposed Conciliation Agreement in VCRB 2022-03 with Gary Keith, former City Council Member, City of Clarksburg, pursuant to W. Va. Code § 6B-2-4(s) and § 6-9A-4(12). Ms. Disibbio gave a second, and the motion carried.

VCRB 2008-20 Roger Lee Wolfe (deceased)

Upon return to the public session, Ms. Davis made a motion that based upon the Application for Waiver of Lien, the documentation provided, and the totality of the circumstances relating to Mr. Wolfe's health and finances at the time of his death, that the Commission waive its lien and claims against the Estate of Roger Lee Wolfe. Ms. Singleton gave a second, and the motion carried.

VCRB 2022-03 Gary Keith, former City Council Member, City of Clarksburg

Ms. Davis moved that the Commission accept the proposed Conciliation Agreement in the matter VCRB 2022-03 Gary Keith, former City Council Member, City of Clarksburg. Mr. Cottle gave a second, and the motion carried.

Adjournment

Ms. Singleton made a motion to adjourn, and Mr. Cottle seconded the motion. The motion passed, and the meeting was adjourned.
