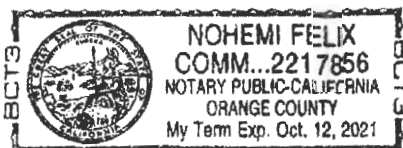

## INSTRUCTIONS
