

AMENDMENT TO FINAL DECISION AND ORDER

The West Virginia Ethics Commission hereby amends the Final Decision and Order entered in the above-captioned matter on October 1, 2015, to reflect that Respondent Paula Boggs may personally pay the fine of \$1,000 and the reimbursement amount of \$1,310.45 on the following payment schedule:

- Paula Boggs shall pay the amount of \$500 by December 1, 2015;
- Paula Boggs shall pay the amount of \$150 per month by January 1, 2016; February 1, 2016; March 1, 2016; April 1, 2016; May 1, 2016; June 1, 2016; July 1, 2016; August 1, 2016; September 1, 2016; October 1, 2016, and November 1, 2016, and
- Paula Boggs shall pay the amount of \$160.45 by December 1, 2016.
