#### Overview

Golden Horseshoe Strategies, LLC is proud to respond to this request from the Wetzel County Assessor's Office. Conrad Lucas serves as the principal lobbyist for Golden Horseshoe Strategies, LLC and would represent the Wetzel County Assessor's Office for professional services and register as a lobbyist with the West Virginia Ethics Commission.

#### Background

Conrad Lucas serves as the West Virginia consultant for Capitol Resources, LLC, d/b/a in West Virginia as Golden Horseshoe Strategies, LLC. Capitol Resources, LLC is one of the largest government relations firms in the Southeast with a presence in Texas, Louisiana, Mississippi, Alabama, Georgia, Florida, Tennessee, South Carolina, West Virginia and Washington, DC. Lucas has been part of Capitol Resources since 2014 and represents a variety of clients at the state capitol as well as leading numerous grassroots/grasstops campaigns on political and legislative matters. Lucas previously chaired the West Virginia Republican Party and oversaw historic successes while also serving as a member of the Republican National Committee. As a lobbyist, Lucas has demonstrated success in tort reform, procurement, education and administrative matters. He began his career as an aide to now U.S. Senator Shelley Moore Capito (R-WV). An attorney by training, Lucas holds degrees from Vanderbilt (B.S. and Ed.D.),

Harvard (Ed.M.) and Tulane (J.D.). He and his wife, LeFlore Barbour Lucas, reside in Charleston, WV. Lucas's resume is included as an attachment.

#### Scope of Services

The scope will begin with a focus on legislation related to real property and personal property assessment legislative matters at the West Virginia Capitol and may also include other matters impacting the Wetzel County Assessor's Office related to administrative law, appraisal matters and rulemaking as determined by Scott Lemley.

Specifically, the focus will include:

- 1) Oil, Natural Gas, and Natural Gas Liquids assessment legislation for working interest, royalty interest, and overriding royalty interest,
- 2) Constitutional Amendment increasing the Homestead Exemption from \$20,000 to \$25,000,
- 3) Expanding the eligibility for Tax Classification Two (02) on real estate parcels,
- 4) Constitutional Amendment eliminating the personal property tax on inventory,
- 5) Any other potential legislation that is introduced that may impact the assessment and taxability of real and personal properties within Wetzel County.

Services include advocacy and issues management with legislative leadership and key decisionmakers on the legislative Rules, Judiciary, Finance and Government Organization committees. Managing matters related to assessment laws related to ad valorem taxation, property taxes and others that are key to effective assessment in West Virginia will include coalition building, legislative drafting and direct issue advocacy. Reporting to the Wetzel County Assessor's Office will include real-time updates on matters as needed, status reports and other communication determined during the duration of the engagement.

#### Compliance

Conrad Lucas and Golden Horseshoe Strategies, LLC will comply with all laws, rules and regulations applicable to activities related to this Agreement and its performance hereunder, including but not limited to any and all registration, reporting and other applicable requirements.

#### **Proposed Contract Budget**

Beginning July 1, 2023, Golden Horseshoe Strategies, LLC respectfully proposes a monthly retainer of \$5,000 (five-thousand dollars) for a minimum of one-year totaling \$60,000 (sixty-thousand dollars) plus pre-approved expenses. Also, during the Legislative Session months from January 1, 2023 – April 15, 2023, Golden Horseshoe Strategies proposes additional support from Hallie Mason with Mason Consulting for a flat fee of \$25,000 (twenty-five thousand dollars) for additional legislative monitoring matters. Billing would be submitted at the conclusion of each month. Mileage reimbursements would be at the current IRS stated rates and included in monthly billing. Note that the proposal is subject to conversation with Scott Lemley.
