The West Virginia Beverage Association hosted its annual "Soft Drink Day at the Legislature" on March 1, 2017. Companies participating in this event were: Coca-Cola Consolidated, Pepsi Bottling Group and Dr Pepper/7Up. Approximately 45 - 55 beverage industry employees participated in this event. At least three other special interest groups were holding information days at the Legislature on this day as well; therefore, it is not possible to accurately estimate the number of people in the Capitol other than to indicate that the Capitol was very crowded on this day.

Beverage displays were placed around the rotunda area of the Capitol with complimentary beverage products offered to the general public, public officials, employees, Capitol visitors, or other lobbyists in the area. Informational booths with material were also provided to the public. The approximate total cost of this event was \$3,014.56.
