- Lobbyists must file a Lobbyist Activity Report even if no lobbying activity or expenditures were made during the reporting period.
- If you represent multiple employers, itemize spending figures per employer in separate columns. Use additional Lobbyist Activity Reporting forms if necessary.
- Please carefully review and complete the forms in their entirety. Incomplete forms will be returned.

The sponsor of a grass roots lobbying campaign is required to file reports with the WV Ethics Commission on January 15, May 15, and September 15 of each year.
