Re: Joint Reception Held December 5, 2022

On December 5, 2022, a joint reception was held to honor West Virginia's courts, justices and judges, and practicing attorneys. The sponsors for this event were:

Defense Trial Counsel of West Virginia Center for Consumer Law and Education West Virginia Association for Justice West Virginia Bar Association

West Virginia State Bar

West Virginia University College of Law

West Virginia Women Attorneys

Of these sponsors, only the West Virginia Association for Justice and the Defense Trial Counsel of West Virginia have lobbyists registered with the West Virginia Ethics Commission. Both WVAJ and DTCWV donated \$1000 toward event costs.

The reception invitation was sent to current and newly elected members of the West Virginia Legislature, the West Virginia Supreme Court and staff; the West Virginia Intermediate Court and staff, West Virginia Circuit Court Judges, and West Virginia Family Court Judges. A total of 32 people from these groups attended.

Final event costs totaled \$8333.94. A total of 150 people attended the event, making the cost per Attendee \$55.56. At that rate, the cost for elected officials and their staff totaled \$1,777.92.

The \$1,000 donations from WVAJ and DTCWV represent 12 percent of total cost each. The amount of final costs for each organization is \$213.35. This is the amount provided on the 2022-03 Lobbyist Activity Report and Schedule B.
