#### **Approval of minutes**

### **Contract Exemption 2020-01**

Mr. Wolfe called upon Ms. Kirk to present Contract Exemption 2020-01, which was requested by the Town of Fairview, to the Commission for its consideration. Ms. Kirk presented the proposed Contract Exemption. Ms. Singleton moved to accept the Contract Exemption. Mr. Walker seconded the motion, which passed unanimously.

### **Contract Exemption 2020-02**

Mr. Wolfe called upon Ms. Kirk to present Contract Exemption 2020-02, which was requested by the Town of Fairview, to the Commission for its consideration. Ms. Kirk presented the proposed Contract Exemption. Ms. Singleton moved to accept the Contract Exemption. Mr. Harman seconded the motion, which passed unanimously.

#### **Approve Modified Guideline**

Mr. Wolfe called upon Ms. Stepto to give a summary of the proposed changes to the Guideline entitled "W. Va. Code § 61-10-15 Governing County Officials and County Schools." A motion was made by Mr. Walker to approve this Guideline as presented. Ms. Davis seconded the motion, which passed unanimously.

### **Approve P-card Monthly Report**

The Commission reviewed purchases on the P-card monthly report for November 2019. Mr. Walker moved that the report be accepted as presented. Ms. Davis seconded the motion, which passed unanimously.

## **Report from Administrative Law Judge Committee**

Mr. Knopp summarized for the Commission Administrative Law Judge Advisory Opinion 2019-01-R, which was issued by the Administrative Law Judge Committee during a meeting on November 7, 2019.

# **Report from Personnel Committee**

A motion was made by Ms. Davis that the Commission go into executive session pursuant to W. Va. Code § 6-9A-4(b)(2)(A), relating to matters arising from the appointment, employment, retirement, promotion, transfer, demotion, disciplining, resignation, discharge, dismissal or compensation of a public officer or employee. Mr. Harman seconded the motion, which passed unanimously. All staff, except Ms. Stepto, left the meeting room. Ms. Stepto left the meeting room for a portion of the meeting.

The Commission returned to public session, and Ms. Stepto and Ms. Briggs returned to the meeting room. A motion was made by Mr. Walker that the Commission accept the evaluations of all staff as presented by Ms. Stepto. Ms. Singleton seconded the motion, which passed unanimously.

Ms. Davis made a motion to adjourn, and Mr. Harman seconded the motion. The motion passed unanimously, and the meeting was adjourned.
